

## River Line earthworks hearing postponed

The Cobb County Commission has postponed consideration of OB-40, the Other Business item that relates to a trench and two artillery positions on the Providence property on the south side of Veterans Memorial Highway (see October newsletter). As is common, the Cobb commissioners defer to the commissioner representing the area in which the subject property is located. In response to communications from neighborhood groups and preservationists, District 4 Commissioner Lisa Cupid asked that the matter be held until at least



21 November, writing "I need to better understand the history of this site and Pulte's role at Park Avenue and Shoupade Park before moving forward. It is my understanding that the earthworks at Providence have been disturbed although there is supposed to be a significant surrounding buffer. Again I just would like more time to understand and address these issues in this zoning."

#### **Shoupade Park celebration**

On 23 September, River Line Historic Area celebrated the replacement of the historical markers at Shoupade Park in Cobb County. <a href="www.riverline.org">www.riverline.org</a> Roberta Cook, who has fought to preserve the River Line for over fifteen years, hosted the event, which was covered by the *Atlanta Journal Constitution* and other media. Cobb County Board of Commissioners Chair Mike Boyce attended, and Mary-Elizabeth Ellard represented GBA, which provided the content for the markers. Ms. Cook took the opportunity to discuss better park maintenance with the Parks Director.

#### Confederate monument and street name news

On 13 October, the City of Atlanta announced formation of an advisory committee to review Confederate street names and city-owned monuments. The committee plans to solicit feedback from historians, business leaders, and residents to provide context and perspective for the landmarks in the city limits and will ultimately recommend how the community can be involved in determining the handling of each case. The first committee meeting was on 18 October.

On 24 October, the DeKalb County Board of Commissioners approved a resolution calling for the removal of the 1908 Confederate monument behind the old courthouse in Decatur, though a 2001 state law would seem to prohibit relocating the monument except to preserve it.

## House that served as Confederate headquarters may be torn down

Oakton, a house at 581 Kennesaw Avenue in Marietta that served as a headquarters for Major General W.W. Loring in June 1864, may be sold and torn down. The house has been for sale for over two years, but the only offers have been from developers who want to remove the house and put in 13 or more new houses. #### Time to apply for annual battlefield preservation planning grants

The American Battlefield Protection Program (ABPP) annual planning grant process is underway. The web site <a href="www.nps.gov/abpp/grants/grants.htm">www.nps.gov/abpp/grants/grants.htm</a> will have guidelines and an application form. If you don't have access to the internet, call ABPP grants manager Kristen McMasters at 202 354 2037. Completed applications must be postmarked by 2 January 2018.

These ABPP grants cannot be used to acquire land, unlike those through the Land and Water Conservation Fund. Georgia projects received grants in 2009, 2010, and 2012.
