Last chance to register for 12-15 March tour in Columbus

GBA's annual tour will be 12-15 March 2020 and will be based in Columbus. **Cost & Registration:** \$430. Register online at www.georgiabattlefields.org/tours.aspx, or mail check payable to Georgia Battlefields Association to PO Box 669953, Marietta GA 30066.

Hotel: Hampton Inn at 2870 S. Lumpkin Rd, Columbus, which fronts on Fort Benning Road and is near the entrance to the post. The GBA group rate is \$129, but the ubiquitous taxes push the actual rate to \$155. We've passed the cutoff date (15 February) to get the GBA rate, but the hotel manager has been very accommodating; so call 706 660 5550 and see if you can sweet talk your way into a bargain rate.

During the Thursday evening reception at the hotel, we'll have a raffle to see who fires the big gun during our visit to the National Civil War Naval Museum. We'll also have a book exchange. If you're flying into the Atlanta airport and need a ride, e-mail us. We'll likely be able to help.

Georgia Battlefields Association turns 25

GBA was established in March 1995 as a private, non-profit organization dedicated to preserving Georgia's Civil War sites, most of which are privately owned.

For example, GBA has worked with national, state, county, and city governments and non-governmental preservation organizations to:

- Raise funds for and coordinate the purchase of 18.5 acres of the Griswoldville battlefield. GBA deeded the site to Department of Natural Resources, which established a state park.
- Influence the state government to buy over 500 acres of the Resaca battlefield in 2000.
- Help a Cobb County neighborhood association prevent placement of a convenience store near the Kolb Farm, a unit of the Kennesaw Mountain National Battlefield Park. Through both a \$5,000 pledge and a publicity campaign, GBA influenced the Cobb County Commission to purchase 4.2 acres that were then deeded to the National Park Service in 2003.
- Persuade the Cobb County Commission to set aside 4 acres of a proposed 154-unit housing development to protect unique fortifications known as Shoupades. Today, a small park contains the remnants of two of these forts, as well as a supporting artillery site. GBA provided the text and graphics for the four historical markers at the site.
- Place a conservation easement on 473 acres of the Resaca battlefield. Working with American Battlefield Protection Program, American Battlefield Trust, Trust for Public Land, and Gordon County Commission, GBA contributed \$50,000 towards the cost of the easement.
- Purchase 51 acres of the Resaca battlefield. GBA contributed \$75,000, almost half the cost.
- Purchase 7 acres containing Confederate earthworks in Crow Valley, north of Dalton. GBA contributed the entire purchase price of \$25,000.
- Purchase 4 additional acres in Crow Valley for \$15,000.
- Contribute \$20,000 to purchase additional land at Kettle Creek Revolutionary War battlefield.
- Contribute to the cost and texts of ten markers placed by the Georgia Historical Society.
- Contribute \$10,000 towards restoration of the McPherson and Walker monuments in Atlanta.
- Formally comment on proposals to build houses, roads, cell phone towers, and power lines that might affect historic sites.

GBA also owns and maintains 4.7 acres of the New Hope Church battlefield. Overall, GBA has contributed over \$270,000 towards preservation efforts.

To achieve its preservation objectives, GBA must first raise awareness of the existence and status of historic sites in Georgia. To accomplish this objective, GBA has:

- Given over 130 presentations about the history of Civil War sites and their preservation status.
- Conducted over 80 tours of Civil War sites.
- Designed and installed a dozen historical markers.
- Given interviews in support of preservation to local and national media.

GBA does all this without government funding. GBA raises money almost exclusively from membership dues and from conducting tours its members pay to attend. GBA has no paid staff. The GBA trustees are all volunteers, and their only compensation is the satisfaction of working for a worthwhile cause.
